## **Specific entry requirements**

A Bachelor's degree or a professional degree equivalent to a Swedish Bachelor's degree of at least 180 credits. And proficiency in English equivalent to English B/English 6.

## **Objectives**

After completion of the course the student should be able within the area of reproductive health and rights as well as adolescent, maternal, newborn, and child health to:

- Describe, explain and analyse variations in causes and patterns of mortality and morbidity, including their determinants and drivers in and between countries and over time,.
- Describe, explain and critically analyse the main international interventions and policies.
- Describe and evaluate the vulnerability and the risks women and children are exposed to in low and middle-income settings as well as in emergency situations.

- Critically analyse and discuss the 2030 Agenda and the Sustainable Development Goals and how they relate to this field

## Content

- Variations in adolescent, maternal, newborn, and child health and its determinants.
- Main diseases causing mortality and morbidity during the perinatal, childhood and adolescent period.
- The main international reproductive health and rights / adolescent, maternal, newborn, and child health interventions and policies including, but not restricted to, nutrition, abortion / postabortion care, midwifery the "Integrated Management of Childhood Illnesses" (IMCI) and others.
- Vulnerability and risks - in relation to women's position and socio-economic status and in relation to child and adolescent development, maturing and socio-economic environment.

## Teaching methods

The course consists of lectures, group work and self-readings of course literature/course literature studies.

## Examination

Written examination.

The final grade Pass on the course requires Pass on the written exam (or 65% of points) or distinction (90%). The grades used are fail, pass or pass with distinction.

Compulsory participation

The examiner assesses if, and in that case how, absence can be compensated. Before the student has participated in all compulsory parts or compensated absence in accordance with the examiner's instructions, the student's results for the course/respective part will not be registered. Absence from a compulsory part may result in the student having to wait to compensate until the next time the course is given.

Limitation of number of occasions to write the exam

Students who have not passed the regular examination are entitled to participate in five more examinations. If the student has not passed the exam after four participations he/she is encouraged to visit the study advisor. If the student has failed six examinations/tests, no additional examination or new admission is provided.

The number of times that the student has participated in one and the same examination is regarded as an examination session. Submission of a blank examination is regarded as an examination. An examination for which the student registered but not participated in will not be counted as an examination.

If there are special grounds, or a need for adaptation for a student with a disability, the examiner may decide to deviate from the syllabus's regulations on the examination form, the number of examination opportunities, the possibility of supplementation or exemptions from the compulsory section/s of the course etc. Content and learning outcomes as well as the level of expected skills, knowledge and abilities may not be changed, removed or reduced.

## Transitional provisions

Examination will be provided during a time of two years after a possible cancellation of the course. Examination can take place according to an earlier literature list during a time of one year after the date when a major renewal of the literature list has been made.

## Other directives

The students will have the opportunity to give continuous feedback and input during the course to ensure that the course is as student-driven as possible.

Course evaluation will be carried out in accordance with the guidelines established by the Committee for Higher Education.

The course language is English.
