1. Description of any implemented changes since the previous course

A large proportion of the course was moved to the Health Financing course delivered in the previous Fall term. Thus, the entirety of the course content was moved back, and new content was introduced at the end of the course. This content included an introduction to decision analytic modelling including decision tree modelling, and a brief introduction to state transition models. A new examination was created to accommodate the content changes in the course.

2. A brief summary of the students' evaluations of the course
